

# The Ultan Patrick Byrne Family Education Trust Fund

## Background:

In 1997, Judge BPM (Patricia) Byrne founded *The Ultan Patrick Family Byrne Education Trust Fund*. She was the daughter of the late (Dr) Ultan Patrick Byrne and the last surviving member of his family. The Trust was established to honor the memory of her father, her father's heritage and to support university education in British Columbia.

## Criteria:

Bursaries are awarded based on financial need to assist with undertaking and/or completing programs (on a full time basis) in either: medicine, law, engineering or nursing.

Applicants must be enrolled full-time in the aforementioned fields, at the University of British Columbia, University of Victoria or Simon Fraser University.

Applicants must have been born and currently reside in British Columbia.

## Trust Guidelines:

Applicants will be selected on the basis of financial need.

The Bursary will only cover tuition expenses.

The Trust will award a minimum of one bursary each year.

The Trust will pay the University directly for tuition fees.

## Application Process:

1. Complete the following application forms.
2. Include your Social Insurance Number.
3. Include one current signed letter of reference—a letter of reference should be completed by a professor, an employer or someone who knows you in a 'professional' capacity. Please ensure their title and/or credentials are included within the letter. Additionally, please ensure it is current (i.e. the reference letter is written within the last 6 months).
4. Include proof of BC birthplace (i.e. a copy of your passport or birth certificate).

Return original applications to the address listed below. Incomplete applications will not be eligible.
